Context: The Programmes team is essential to delivering <u>ActionAid Ireland's strategy 2022-2027</u> to create a just and caring world where women's human rights are respected through addressing the structural causes of Gender Based Violence (GBV), promoting women's leadership in humanitarian contexts and amplifying feminist alternatives on economic and climate justice. ActionAid Ireland's strategy also makes clear commitments to anti-racism, shifting power and decolonisation, embedding learning and evaluation and safeguarding. Human rights-based approaches are at the heart of ActionAid's work.

The team is comprised of the Head of Programmes, Programme Performance and Learning Coordinator, a Programme and Policy Officer and a consultant, all working closely with Women's Rights Officers and Country Directors in partner countries. The GBV Coordinator is a newly established position within the team and will play a key role in the design and implementation of high-quality programming, particularly in responding to, and addressing the structural causes of GBV. ActionAid Ireland recognises the intersecting realities of pervasive GBV, conflict and instability, the impact of climate crisis and governance challenges and strives for its programmes to improve its interventions at different levels (interpersonal, community, institutional) to realise human rights.

Action ActionAid Ireland's largest programme is the Women's Rights Programme III (WRP III) 2023-2027. It is funded by Irish Aid, and implemented across three countries Kenya, Nepal and Ethiopia. This programme aims to achieve equal opportunities for women in safe communities. It builds on the success of WRP II and focuses on two key outcomes across the three countries a) reduction in GBV for women and girls and 2) greater economic empowerment for women in marginalised communities. There will also be an additional focus on climate justice within the programme in order to combat and mitigate the impact of climate change on women's rights. Within the scope of this programme, the GBV Coordinator will be responsible for providing technical expertise and leadership in Ethiopia, Kenya and Nepal on approaches that prevent, mitigate and respond to GBV. They will also be responsible for ensuring a holistic approach by integrating Human Rights Based Approach (HRBA) and Behaviour Change approach and ensuring they are survivor centred. The GBV Coordinator will also be responsible for coordinating, and applying learning, and strengthening skills and knowledge in the areas of GBV and women's rights. They will represent ActionAid at networks and relevant platforms to share learnings, raise voices and profiles of ActionAid partners and draft and disseminate resources to enhance the organisation's policy priorities.

The position requires deep experience in addressing GBV and gender transformative programming, including the ability to link this experience to policy dialogues addressing GBV and promoting women's rights. It requires strong commitment to shifting power and locally



led development and applying intersectional feminist approaches throughout programme and policy initiatives that deliver on ActionAid Ireland's strategy.
